

# User Agreement

## for Football Bets Prediction Service «MetaBet».

### 1. General Provisions

- 1.1. <https://meta-bet.online> (hereinafter referred to as— «**MetaBet**») offers the Internet user (hereinafter referred to as the User) to use its service under the terms set forth in this User Agreement (hereinafter referred to as the "Agreement", "UA"). The Agreement comes into force from the moment the User expresses consent to its terms in the manner provided for in clause 1.3 of the Agreement.
- 1.2. **MetaBet** provides Users with access to the service, including navigation tools, communication, search and storage of various kinds of information, content personalization, making purchases, etc. The current **MetaBet** service, as well as any of its developments and/or the addition of new ones, is the subject of this Agreement.
- 1.3. By starting to use the service or by going through the registration procedure, the User is deemed to have accepted the terms of the Agreement in full, without any reservations or exceptions. If the User disagrees with any of the provisions of the Agreement, the User may not use the **MetaBet** service. In case **MetaBet** has made any changes to the Agreement with which the User does not agree, he must cease using the **MetaBet** service.
- 1.4. Access to certain functions of the **MetaBet** service is provided through the conclusion of a contract between the User and **MetaBet** (hereinafter referred to as the Subscription), in accordance with clause 0 of the Agreement.
- 1.5. Information provided by the **MetaBet** service about sports events (hereinafter referred to as Predictions) is not a call to action for the User and is positioned as an opinion.
- 1.6. Recommendations of the **MetaBet** service are not a call to action for the User and are positioned as an opinion.
- 1.7. The site in no way conducts gambling/betting activities, including not accepting bets and not making payments of money.
- 1.8. The User should not consider the information obtained on the Site in the form of predictions for the outcomes of upcoming sports events as absolutely reliable.

## 2. User Registration. User Account

- 2.1. To use the **MetaBet** service and/or some of its individual features, the User must go through the registration process, as a result of which a unique account will be created for the User.
- 2.2. The User's personal information contained in the User's account is stored and processed by the **MetaBet** service in accordance with the terms of the "Privacy Policy" at <https://metabet.online>.
- 2.3. The User is solely responsible for the security (resistance to guessing) of the chosen means of access to the account, as well as for ensuring their confidentiality. The User is solely responsible for all actions (and their consequences) within or using the **MetaBet** service under the User's account, including cases of voluntary transfer of data for access to the User's account to third parties on any terms (including contracts or agreements). At the same time, all actions within or using the **MetaBet** service under the User's account are considered to be performed by the User himself, except in cases where the User, in the manner provided for by clause **Ошибка! Источник ссылки не найден.**, has notified **MetaBet** of unauthorized access to the **MetaBet** service using the User's account and/or any violation (suspicions of violation) of the confidentiality of their means of access to the account (password).
  - 2.3.1. The User may notify **MetaBet** of any case of unauthorized (not permitted by the User) access to the **MetaBet** service using the User's account and/or any violation (suspicions of violation) of the confidentiality of their means of access to the account.
  - 2.3.2. The User has the right to create only one account on the **MetaBet** service. Also, the owner of the account can only be one User, group registration, purchase, and other actions in the **MetaBet** service are prohibited. In case of suspicion of violation of this clause, the service has the right to stop the operation of the User's account.
  - 2.3.3. Some categories of User accounts may limit or prohibit the use of some individual features of the **MetaBet** service if this is provided for in the terms of use of a particular subscription.
  - 2.3.4. **MetaBet** has the right to block or delete the User's account, as well as to prohibit access using any account to certain features of the **MetaBet** service in case of violation of the Agreement by the User.

### 3. General Terms of Use

- 3.1. **MetaBet** is not responsible for the financial results of players.
- 3.2. **MetaBet** has the right to set restrictions on the use of services for all Users, or for individual categories of Users (depending on the subscriptions issued), including the presence/absence of individual service functions.
- 3.3. **MetaBet** has the right to send informational messages to its users. By using the **MetaBet** service, the User also gives their consent to receive advertising messages in accordance with part 1 of Article 18 of the Federal Law "On Advertising". The User has the right to refuse to receive advertising messages by using the corresponding functionality of the service within which or in connection with which the User received advertising messages.

## 4. Terms of Use of the MetaBet Service

- 4.1. The User is solely responsible to third parties for their actions related to the use of the Service, including if such actions lead to the violation of the rights and legitimate interests of third parties, as well as for compliance with the legislation when using the Service.
  - 4.1.1. The cost of the subscription is not considered when calculating profit.
- 4.2. The User is not allowed to:
  - 4.2.1. Disrupt the normal operation of the **MetaBet** service website
  - 4.2.2. Use another User's account
  - 4.2.3. Unauthorized access to individual service functions
  - 4.2.4. Perform actions aimed at violating this Agreement
- 4.3. The User has the right to:
  - 4.3.1. Contact with any question using the service's open contacts
  - 4.3.2. Use the service in their interests, not contradicting the clauses of this Agreement
  - 4.3.3. Access individual functions of the **MetaBet** service in accordance with the subscription issued by the user
  - 4.3.4. Subscribe to any of the subscriptions offered by the service for a fee set by the **MetaBet** service
- 4.4. Users are advised not to deviate from the recommendations of the **MetaBet** service, including Predictions and Artificial Intelligence.
- 4.5. In case of deviation from clause 4.4, the user who has issued a Subscription will have the renewal guarantee canceled, by decision of the administration.
- 4.6. Cases that include clause 4.5:
  - 4.6.1. The User intentionally does not place bets to obtain a subscription renewal in the form of a renewal guarantee

## 5. Terms of Service Provision

- 5.1. The result of the services provided is granting the User access to predictions of sports events outcomes and/or Artificial Intelligence calculations, compiled by the analytical tools of the **MetaBet** service, including computing technology and special algorithms. The service is considered rendered from the moment the User is granted access to the predictions of sports events outcomes on the **MetaBet** resource in accordance with the subscription paid by the User.
- 5.2. By agreeing to the terms of this offer, the User acknowledges and agrees that the actual results of sports events may not match the predicted results, and the further use of the obtained sports events predictions and possible adverse financial consequences are the responsibility of the User.
- 5.3. **MetaBet** does not accept sports bets and is not a bookmaking company.
- 5.4. Predictions appear on the site as they are added using computing technology.

## 6. Refund Policy

- 6.1. Considering the provisions of clauses 5.1, 5.2 of this UA, the User agrees that in case of a discrepancy between the prediction and the actual result of a sports event, the money paid for the subscription is non-refundable. The service is considered rendered from the moment the User is granted access to the predictions of sports events outcomes on the **MetaBet** website in accordance with the subscription paid by the User.
- 6.2. In case the User refuses to receive paid services after being granted access to any individual functions of the **MetaBet** website, the cost of these services is non-refundable, as the service is already considered rendered.
- 6.3. A refund is possible in the event of a technical malfunction on the site that prevented the user from using the service's functionality.
